## NOTICE OF RECEIPT OF APPLICATION AND INTENT TO OBTAIN A MUNICIPAL SEPARATE STORM SEWER SYSTEM (MS4) PERMIT AMENDMENT

**PERMIT NO. WQ0005011000**

**APPLICATION.** Texas Department of Transportation (TxDOT), 125 East 11<sup>th</sup> Street, Austin, Texas 78701, which operates the TxDOT Municipal Separate Storm Sewer System (MS4) throughout the state, has applied to the Texas Commission on Environmental Quality (TCEQ) to amend Texas Pollutant Discharge Elimination System (TPDES) Permit No. WQ0005011000 (EPA I.D. No. TXS002101) to authorize adding the Brownwood District to the regulated statewide TxDOT MS4 boundaries, adding counties, cities, and zip codes to the regulated TxDOT MS4 boundaries, and updating the receiving water bodies list to reflect the addition of new discharge points/outfalls and the removal of segments that do not receive discharges from TxDOT MS4 areas. The Phase I and Phase II MS4 areas are located within the following 23 TxDOT Districts: Abilene, Amarillo, Atlanta, Austin, Beaumont, Brownwood, Bryan, Corpus Christi, Dallas, El Paso, Fort Worth, Houston, Laredo, Lubbock, Odessa, Paris, Pharr, San Angelo, San Antonio, Tyler, Waco, Wichita Falls, and Yoakum Districts. The MS4 areas within the **San Antonio District** include TXDOT right-of-way and facilities in the cities of San Antonio, Alamo Heights, Balcones Heights, Bulverde, Castle Hills, China Grove, Cibolo, Converse, Cross Mountain, Fair Oaks Ranch, Garden Ridge, Helotes, Hill Country Village, Hollywood Park, Kirby, Lackland AFB, Lake Dunlap, Leon Valley, Live Oak, Marion, McQueeney, New Braunfels, Olmos Park, Randolph AFB, Redwood, Santa Clara, Scenic Oaks, Schertz, Seguin, Selma, Shavano Park, Terrel Hills, Timberwood Park, Universal City, Von Ormy, and Windcrest in Bexar, Comal, Guadalupe and Kendall Counties, Texas 78006, 78009, 78015, 78023, 78073, 78108, 78109, 78112, 78123, 78124, 78130, 78132, 78148, 78150, 78154, 78155, 78163, 78201, 78202, 78203, 78204, 78205, 78207, 78208, 78209, 78210, 78211, 78212, 78213, 78214, 78215, 78216, 78217, 78218, 78219, 78220, 78221, 78222, 78223, 78224, 78225, 78226, 78227, 78228, 78229, 78230, 78231, 78232, 78233, 78234, 78235, 78236, 78237, 78238, 78239, 78240, 78242, 78244, 78245, 78247, 78248, 78249, 78250, 78251, 78252, 78253, 78254, 78255, 78256, 78257, 78258, 78259, 78260, 78261, 78263, 78266, 78655, 78666. The discharge route is from the municipal separate storm sewer system to the surface water in the State. TCEQ received this application on June 4, 2021. The permit application is available for viewing and copying at the San Antonio District Office, 4615 Northwest Loop 410, San Antonio, Texas.

The application is subject to the goals and policies of the Texas Coastal Management Program and must be consistent with the applicable Coastal Management Program goals and policies.

**ADDITIONAL NOTICE.** TCEQ's Executive Director has determined the application is administratively complete and will conduct a technical review of the application. After technical

review of the application is complete, the Executive Director may prepare a draft permit and will issue a preliminary decision on the application. **Notice of the Application and Preliminary Decision will be published and mailed to those who are on the county-wide mailing list and to those who are on the mailing list for this application. That notice will contain the deadline for submitting public comments.**

**PUBLIC COMMENT / PUBLIC MEETING.** You may submit public comments or request a public meeting on this application. The purpose of a public meeting is to provide the opportunity to submit comments or to ask questions about the application. TCEQ will hold a public meeting if the Executive Director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing.

**OPPORTUNITY FOR A CONTESTED CASE HEARING.** After the deadline for submitting public comments, the Executive Director will consider all timely comments and prepare a response to all relevant and material, or significant public comments. **Unless the application is directly referred for a contested case hearing, the response to comments, and the Executive Director's decision on the application, will be mailed to everyone who submitted public comments and to those persons who are on the mailing list for this application. If comments are received, the mailing will also provide instructions for requesting reconsideration of the Executive Director's decision and for requesting a contested case hearing.** A contested case hearing is a legal proceeding similar to a civil trial in state district court.

**TO REQUEST A CONTESTED CASE HEARING, YOU MUST INCLUDE THE FOLLOWING ITEMS IN YOUR REQUEST:** : your name, address, phone number; applicant's name and proposed permit number; the location and distance of your property/activities relative to the proposed facility; a specific description of how you would be adversely affected by the facility in a way not common to the general public; a list of all disputed issues of fact that you submit during the comment period and, the statement "[I/we] request a contested case hearing." If the request for contested case hearing is filed on behalf of a group or association, the request must designate the group's representative for receiving future correspondence; identify by name and physical address an individual member of the group who would be adversely affected by the proposed facility or activity; provide the information discussed above regarding the affected member's location and distance from the facility or activity; explain how and why the member would be affected; and explain how the interests the group seeks to protect are relevant to the group's purpose.

Following the close of all applicable comment and request periods, the Executive Director will forward the application and any requests for reconsideration or for a contested case hearing to the TCEQ Commissioners for their consideration at a scheduled Commission meeting.

The Commission may only grant a request for a contested case hearing on issues the requestor submitted in their timely comments that were not subsequently withdrawn. **If a hearing is granted, the subject of a hearing will be limited to disputed issues of fact or mixed questions of fact and law relating to relevant and material water quality concerns submitted during the comment period.**

**MAILING LIST.** If you submit public comments, a request for a contested case hearing or a reconsideration of the Executive Director's decision, you will be added to the mailing list for this specific application to receive future public notices mailed by the Office of the Chief Clerk. In addition, you may request to be placed on: (1) the permanent mailing list for a specific applicant name and permit number; and/or (2) the mailing list for a specific county. If you wish to be placed on the permanent and/or the county mailing list, clearly specify which list(s) and send your request to TCEQ Office of the Chief Clerk at the address below.
